I am aware of, capable of, and will take responsibility for placing upon myself and/or my child (if applicable) appropriate physical limitations reasonably calculated to avoid illness or injury and agree that Hadassah (as defined below) is not responsible for imposing on me and/or my child (if applicable) any such limitations. In consideration of my and/or my child's (if applicable) acceptance for participation in the activity and by signing below, I, on behalf of myself, my child, my family members, next of kin, heirs and representatives agree to (i) Release, waive and discharge the above-named Chapter/Region of Hadassah, Hadassah, the Women's Zionist Organization of America, Inc., and each of their respective affiliates, related entities, officers, directors, employees, volunteers, donors, members, agents and representatives (hereinafter collectively "Hadassah") from any and all claims and liability of any kind whatsoever, past, present and future, both known and unknown, including those which have not yet arisen or matured, whether in law or in equity, arising from, related to or in connection with my and/or my child's (if applicable) participation in the activity, including but not limited to, claims for negligence or any intentional act on the part of Hadassah or any other person or entity (collectively, "Claims"); (ii) Covenant not to sue Hadassah with respect to any and all Claims; and (iii) Indemnify, defend and hold harmless Hadassah from any and all Claims and any and all liability, damage, cost, loss and expense (including attorneys' fees and expenses) arising from, related to, or in connection with: (A) my and/or my child's (if applicable) acts and omissions and any participation or involvement by me and/or my child (if applicable) in the activity, and (B) any and all Claims made at any time, past, present, or future, by me, my child, or any of my family members or any person to whom I or my child are related by blood, adoption or marriage, or their heirs, representatives, agents, successors or assigns.

I hereby consent to the exercise of exclusive personal jurisdiction of the courts of the State of New York and the federal courts sitting in New York in connection with any matter arising from, related to, or in connection with the walkathon. This consent, release and indemnification are intended to be as broad and inclusive as permitted by the laws of the State of New York, and if any term or provision is declared invalid by a court of competent jurisdiction, the remaining terms and provisions of this consent, release and indemnification shall remain unimpaired and in full force and effect.
