

## **Official Rules of the Hadassah Israeli Products Fair Raffle:**

The Charlotte Chapter of Hadassah is sponsoring a Fundraising Raffle ("**Raffle**") pursuant to North Carolina General Statutes § 14-309.15 (Raffles). The Charlotte Chapter is a unit of Hadassah, The Women's Zionist Organization of America, Inc., which is a New York not-for-profit corporation, having its principal place of business at 40 Wall Street, New York, NY 10005, and a tax-exempt organization under Section 501(c) (3) of the Internal Revenue Code. The Raffle is to benefit Hadassah and is offered only in Charlotte, North Carolina.

By purchasing a Raffle ticket ("**Ticket**") the entrant agrees to be bound by these Official Rules. As used in these Official Rules, the term "Hadassah" includes Hadassah, The Women's Zionist Organization of America, Inc., the Charlotte Chapter of Hadassah, their affiliates and related entities, and each of their respective officers, directors, employees, volunteers, members, agents, representatives, successors and assigns. The Raffle is subject to all applicable federal, state, and local laws and regulations, and is void wherever prohibited or restricted by law. Tickets are not tax-deductible contributions.

### **Eligibility:**

The Raffle is open only to legal residents of North Carolina, 21 years of age or older at the time of entry. Entrants need not be members of Hadassah, The Women's Zionist Organization of America, Inc. at the time of entry, but in order for the winner to collect the prize the winner must be or become a member of Hadassah, the Women's Zionist Organization of America, Inc. The Charlotte Chapter of Hadassah's and Hadassah, The Women's Zionist Organization of America, Inc.'s employees, board members, and committee members responsible for organizing the Raffle and those with whom they reside and their immediate family members (including spouses, parents, siblings, and children) are not eligible to enter the Raffle.

### **How to Enter:**

Ticket sales begin on September 11, 2015 and end on November 22, 2015 at 1:30 p.m. or when all Tickets are sold, whichever comes first (the "**Entry Deadline**"). To enter the Raffle, an entrant must purchase a Ticket in person at the front desk of the Levine Jewish Community Center located at 5007 Providence Road, Charlotte, North Carolina 28226 during regular business hours (Monday-Thursday: 5:30am-9:30pm, Friday: 5:30am – 6:00pm; Saturday: 12:00pm – 7:00pm; Sunday: 7:00am-7:00pm) using cash, check or money order made payable to "Charlotte Chapter of Hadassah" or by providing a valid credit card. The purchase price per ticket is \$72.00. There is also an option to purchase Tickets at a discounted price of \$500.00 for eight Tickets. A maximum of 250 tickets will be available for sale. There is

no limit to the number of available individual Tickets that an eligible entrant may purchase, subject to the cap on the maximum number of tickets available for sale.

Hadassah accepts Visa, MasterCard and Discover. Credit card payments are processed immediately and Ticket(s) is/are issued following credit card approval. Payments that are denied shall disqualify the Ticket and entrant will be liable for all fees incurred by Hadassah. Payment must be made in U.S. Dollars. Refunds will only be granted at the exclusive discretion of Hadassah.

Entries must be received prior to the Entry Deadline. Hadassah is not responsible for lost, late, illegible, misdirected or incomplete entries. A Ticket will be void and a prize not redeemable if the Ticket was stolen, resold, exchanged, non-issued, ineligible, altered, and counterfeit in whole or in part, defective, printed in duplicate, printed/produced in error or otherwise deemed ineligible by Hadassah in its sole and absolute discretion. It shall be the sole responsibility of the entrant to verify the accuracy and condition of the data printed on the Ticket at the time of purchase.

The winning Ticket will be drawn at random on November 22, 2015 during Hadassah's Israeli Products Fair being held at Sam Lerner's Center located at 5007 Providence Road, Charlotte, North Carolina 28226 at approximately 1:45 p.m. (the "**Drawing**") and the winner will be announced at the Drawing. The winner need not be present at the Drawing to win. If the winner is not present at the Drawing, she or he will be notified by e-mail or phone using the email address or phone number she or he provided when purchasing the Ticket. It is the entrant's sole responsibility to ensure that contact information provided at time of purchase is correct. Hadassah is not responsible for incorrect e-mail addresses or phone numbers.

**Prize/Odds of Winning:**

The winner of the Raffle will receive a trip to Israel for the winner and her/his adult travel companion on an Ayelet Tours, Ltd. ("Ayelet") operated 2016 Hadassah Mission, with the number of days, hotels, meals and ground transportation dependent upon the Hadassah Mission the winner selects. Please see <http://www.ayelet.com/hadassah.html> for trip options and details. All travel must start by the date of the last Hadassah Mission in December of 2016. Hadassah Missions are subject to availability and are subject to change without notice. Any items not expressly stated on the above website as being included in the package for paying Hadassah Mission participants for the particular trip selected by the winner are not included in the prize, except that the winner and her/his adult travel companion will each receive a \$1,000 allowance to be used towards airfare to Israel which must be booked through Ayelet. The winner

and her/his adult travel companion are responsible for all other costs associated with the prize, including, but not limited to, the difference, if any, between the actual cost of airfare to Israel and the allowance stated above if such difference is a negative amount, any accommodations and transportation needed to meet the flight to Israel and after the return flight from Israel, border taxes or visas, items of a personal nature, travel insurance, departure taxes and fuel surcharges.

**Any and all taxes on the prize, and any other costs, fees and expenses, are the sole responsibility of the winner and Hadassah has no liability with respect to same. Hadassah is required to collect withholding tax and report the raffle prize on an I.R.S. Form W-2G, Form 945 or similar tax form for tax withholding purposes. The winner will be required to submit the applicable withholding tax to Hadassah in order to collect the prize.**

The maximum fair market value of the prize is estimated at an amount no more than nine thousand eight hundred dollars (\$9,800). The actual value of the prize may vary based on the Hadassah Mission selected, time of travel and airfare fluctuations. No prize substitution shall be permitted except at the sole discretion of Hadassah. Hadassah reserves the right to award a prize of equal or lesser value if the selected Hadassah Mission is unavailable. Notwithstanding anything to the contrary contained herein, if Ayelet ceases to operate the Hadassah Missions on Hadassah's behalf, the prize will not include a trip to Israel for the winner and her/his adult travel companion on a 2016 Hadassah Mission and instead the winner and her/his adult travel companion will receive a comparable trip to Israel through Ayelet on a non-Hadassah Mission. The winner will not be permitted to receive a cash alternative instead of the prize. The prize may be transferred to an individual that meets the eligibility requirements stated herein and all other requirements of these Official Rules. Certain restrictions may apply which are subject to change at the sole discretion of Hadassah. Hadassah is not liable for any expenses incurred as a consequence of any trip cancellation, flight cancellation or flight delay.

A maximum of two hundred and fifty (250) Tickets will be sold. Odds of winning are determined by the total number of entries received, with the maximum odds of 1:250.

**General Conditions:**

By entering, entrants accept and agree to these Official Rules and the decisions of Hadassah, which are final and binding in all respects.

In order to collect the prize, within 15 business days of notification, winner must deliver to Hadassah: (1) Hadassah's sworn affidavit of eligibility, executed by winner, without modification; (2) a valid check, money order or cashier's check made payable to the "United States Treasury" in the required amount of the withholding tax based on the maximum fair market value of the prize as determined by Hadassah and such other written information as required by any applicable taxing authority (including Social Security

Number); (3) proof of identity in forms satisfactory to Hadassah; (4) Hadassah's Disclaimer, Release and Indemnification document, executed by winner and winner's adult travel companion, without modification; (5) the winning Ticket and (6) such other items as are reasonably requested by Hadassah. In the event the winner transfers the prize then the winner need not comply with (2) and (4) above and the eligible individual to whom the prize is to be transferred (otherwise referred to as the "winner" for purposes of these Official Rules) shall comply with (1) – (4) and (6) above within such 15 business day period. The winner and adult travel companion must have passports valid effective as of the travel dates and must complete all documentation required by Hadassah or Ayelet in order to participate on the Mission. A selected potential winner will not be an official winner until the above requirements have been satisfied in Hadassah's sole and absolute discretion. Failure to execute and return the required documents within the specified time period will result in the prize being forfeited.

In the event of non-compliance with any provision of these Official Rules, or if Hadassah is not able to notify the winner, the prize will be forfeited and an alternate winner will be selected at random. Any alternate winner shall be subject to the eligibility and other requirements of these Official Rules.

By entering the Raffle or accepting the prize, each entrant and winner agrees to release, indemnify, defend and hold harmless Hadassah, its related entities and affiliates and each of their respective directors, officers, members, volunteers, agents, employees, representatives, successors and assigns from any and all damages (including, death and physical injury), costs, expenses (including attorney's fees), causes of action, suits, claims, demands, penalties, judgments, liability and loss, of any kind whatsoever, arising out of or in connection with the Raffle, the tour operator, and/or the use, misuse or non-use of the prize, including but not limited to any substitution thereof and any taxes relating thereto.

The rights granted to Hadassah by entrants and winner for the use of information shall be exercised by Hadassah in accordance with Hadassah's Privacy Policy, which can be found at <http://www.hadassah.org/terms-and-condition-and-privacy-policy/privacy-policy.html?referrer=https://www.google.com/> and which may be updated from time to time.

By entering the Raffle or accepting the prize, an entrant and winner gives Hadassah the right to use and publish the entrant's/winner's name, voice, likeness, photograph, biographical and prize information and any other information provided by the entrant/winner by and any all means without notice or compensation to the entrant/winner.

Hadassah reserves the right, at its sole discretion, to disqualify any individual it finds, in its sole discretion, to be tampering with the entry process for or the operation of the Raffle, to be in violation of the Official Rules, or to be acting in a disruptive manner in connection with the Raffle, or with the intent to annoy, abuse, threaten or harass any other person.

**Limitations of Liability:**

Hadassah is not responsible for any incorrect or inaccurate information, including, without limitation, which is caused by tampering or by any of the equipment associated with or utilized in the Raffle or by any technical or human error which may occur. Hadassah is not responsible for user cheating or fraud by any individuals. In no event will Hadassah be liable for any indirect, special or consequential damages. Hadassah reserves the right in its sole discretion to cancel, terminate, modify or suspend the Raffle, in which event Hadassah's liability is limited solely to the refund of Ticket prices to entrants.
